## ABOUT XIAMEN UNIVERSITY

Xiamen University was founded in 1921 by Tan Kah Kee, the well-known patriotic overseas Chinese leader. It is one of Chinese higher-level universities designated

for the state key construction of the “211 Project” and the “985 Project”.



Over the past ninety years, as the result of following the school motto: Pursue Excellence, Strive for Perfection, Xiamen University has accumulated rich experience in offering its educational programmes and has presented its distinctive features in running the programmes. Xiamen University has a graduate school, 24 schools containing 63 departments and 11 research institutes and research centers. With 14 Doctoral degrees in first-class disciplines, and 17 Master degrees in first-class disciplines, the university offers 83 undergraduate programmes, 225 graduate programmes, and 140 PhD programmes. There are 15 Post doctoral research centers, 9 subjects of “national educational centers for talents”, 5 first-class and 9 second-class national key disciplines. Many disciplines of Xiamen University are at the top level in China and have a certain impact abroad.

Xiamen University has a high level team of faculty and staff including 2475 full-time faculty and professional researchers, 1522 professors and associate professors of whom 22 are academicians of Chinese Academy of Sciences and Chinese Academy of Engineering.

The university now has a total enrollment of over 38000 full-time students on campus, including 20575 undergraduates, 15590 master students, 2483 doctoral students, and over 2000 international students.

Xiamen University is now making great strides towards its goal of “building a high-level university well-known both at home and abroad.”

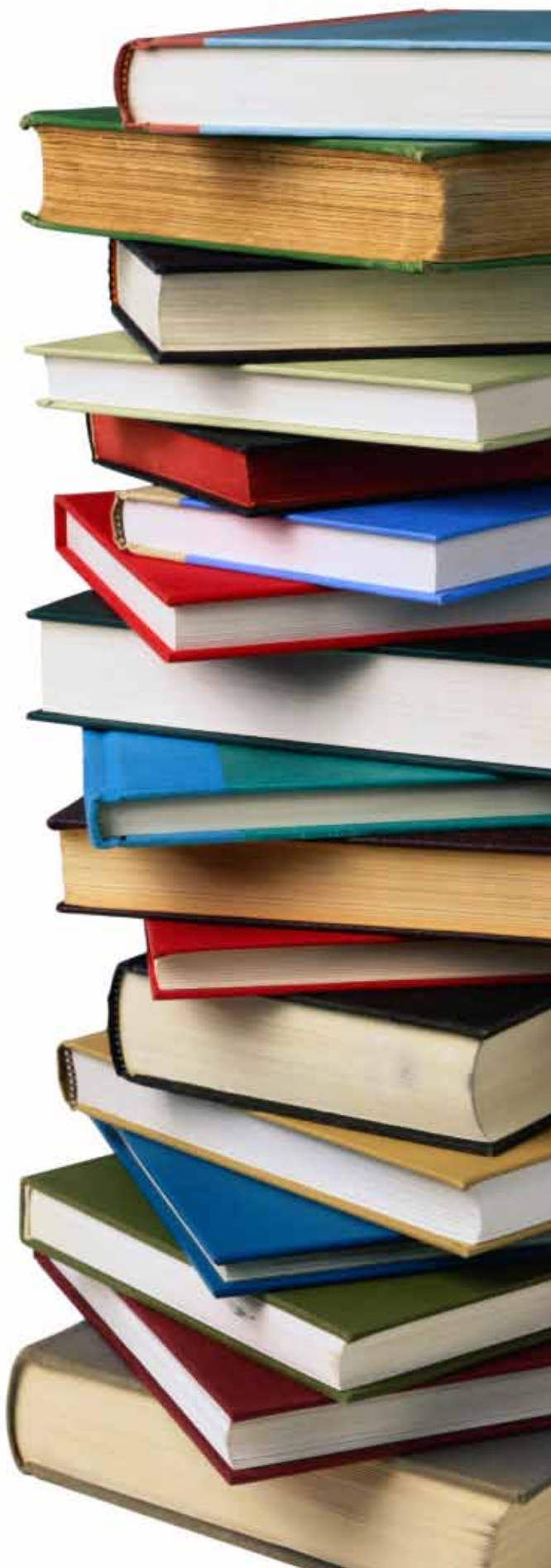


## ABOUT THE CITY OF XIAMEN

# INTRODUCTION

The Xiamen University Overseas Education College is an institute of higher learning specialising in overseas education. It was founded in 1956 under the original name of Overseas Correspondence College, and is one of the oldest institutions in China providing courses for overseas students. The name was changed to Overseas Education College in 1991 with the approval from the Ministry of Education. The

OEC includes the Department of Chinese, the Distance Education Centre, the Office of Overseas Students, and the Research Institute of Overseas Chinese Education. It is one of four national Southeast Asia-oriented Chinese teaching bases in China, and one of the key institutions designated by the Office of Overseas Chinese Affairs of the State Council to support China's neighbouring countries in teaching Chinese.



# ABOUT THE PROGRAMME

In 2011, there're two independent courses in the Overseas Education College Summer Programme, you can chose any-one of them according to your interest.

## Course 1: Eight-week Basic Chinese Class

### > Dates:

May 9<sup>th</sup>, 2011 to July 1<sup>st</sup>, 2011  
Registration will be on May 9<sup>th</sup>; classes begin on May 10<sup>th</sup>.

### > Applicants:

This course is aimed at beginners with little Chinese language background. Students whose Chinese is too advanced for this class may apply to join the regular long-term Chinese programme.

### > Course content:

Language course in the morning and culture courses such as calligraphy, paper cutting, Kung Fu or Chinese painting as well as language practice in the afternoon.

### > Self-paid trips:

Guided tours to Quanzhou, Zhangzhou, Longyan and Wuyi Mountain can be arranged for parties of more than 15 students.

### > Certificates:

The OEC will issue Certificates of Completion of Study indicating the study periods.

### > Credits:

With approval of foreign universities or colleges, the cer-

tificate and transcripts achieved on the OEC Summer Programme will be transferrable into credits at the relevant foreign institutions (8 credits suggested).

### > Application deadline:

April 15<sup>th</sup>. Please contact us for further assistance and advice if you miss the deadline.

### > Visa:

Students should apply for an X or F visa from their local Chinese embassy or consulate taking with them the admission notice and visa application form (jw202) issued by OEC.

### > Enrolment fees:

RMB 240

### > Tuition fees:

RMB 5,600, to include: tuition fees, textbooks, calligraphy tools and copying of teaching materials. Textbooks are provided free to those who join from the beginning of the programme.





## Course 2: Four-week Oral Chinese Class

### > Dates:

July 4<sup>th</sup> to July 29<sup>th</sup>, 2011  
Registration will be on July 4<sup>th</sup>; classes begin on July 5<sup>th</sup>.

### > Applicants:

This course is designed for applicants who have basic oral Chinese skills.

### > Course content:

Language course with the focus on listening and speaking in the morning;  
culture courses such as calligraphy, paper cutting, Kung Fu or Chinese painting as well as language practice in the afternoon.

### > Self-paid trips:

Guided trips to Xiamen, Quanzhou, Zhangzhou, Longyan and Wuyi Mountain can be arranged for parties of more than 15 students.

### > Certificates:

The OEC will issue Certificates of Completion of Study indicating the study periods.

### > Credits:

With approval of foreign universities or colleges, the certificate and transcripts achieved on the OEC Summer

Programme will be transferrable into credits at the relevant foreign institutions (4 credits suggested).

### > Application deadline:

June 17<sup>th</sup>. Please contact us for further assistance and advice if you miss the deadline.

### > Visa:

Students should apply for an X or F visa from their local Chinese embassy or consulate taking with them the admission notice and visa application form (jw202) issued by OEC.

### > Enrolment fees:

RMB 240

### > Tuition fees:

RMB 3,200 to include: tuition fees, textbooks, calligraphy tools and copying of teaching materials. Textbooks are provided free to those who join from the beginning of the programme.

# NOTE

1. Students who complete the eight-week basic Chinese class may apply to join the China Study programme in July on payment of an extra tuition fee of RMB 4,800.

2. Course content given above is for example and may change based on practical needs. A formal timetable will be issued at registration.

3. Group co-operation: In the event of any institution or organisation being able to gather more than 15 suitable applicants, OEC can open a separate course for which the tuition fees, programme and time would be open for negotiation. XMU already operates regular China Study programmes for the University of North Carolina at Chapel Hill, Council for Christian Colleges and Universities, Eckerd College and Bentley College in the USA, and University College Utrecht in the Netherlands.

## INTRODUCTION

The International Ocean Sciences Summer Programme and Doctoral Forum is hosted by the Laboratory of Marine Environmental Science (MEL), which was founded in 1995 and promoted to state level as the “State Key Laboratory of Marine Environmental Science (Xiamen University)” in March 2005. MEL is currently a primary research institution carrying out marine environmental science research in China.

MEL now has 48 scientists, 31 technicians, 27 research assistants and 4 administrative staff. Dur-

ing the past 6 years, MEL scientists have published 468 peer reviewed papers in SCI journals, and have won 17 awards at the national or provincial level.

MEL is dedicated to cutting-edge research in the field of marine environmental science with special focus on biogeochemical processes, mechanisms and their ecological effects. The ultimate goal of MEL is to be an internationally recognized institution in advanced marine environmental science and a platform for international academic exchange and cooperation.

# INTRODUCTION

The Wang Yanan Institute for Studies in Economics Summer Programme for Economics and Finance is held annually in July in Xiamen, China. Although it is hosted by WISE and the MOE Key Laboratory of Econometrics at Xiamen University, it is jointly organised by the Centre for Forecasting Science of the Chinese Academy of Sciences, the Journal of Econometrics and a number of other prestigious academic institutions both

proved popular with the participants. The 2006 Summer Programme on Econometrics and Financial Econometrics received special praise from the Chinese Ministry of Education. The aims of WISE include promoting the internationalisation and the standardisation of teaching and research, which constitutes the rationale for these summer programmes. Through this, WISE has had a positive influence on education in Southern China, and



domestic and foreign.

WISE has held six summer programmes since 2005, with the aim of introducing fundamental theories and cutting-edge information on such subjects as econometrics, finance, micro-economics, and experimental economics, to faculty and students of Departments of Economics and to management staff at domestic universities and institutions. They have all

become widely known as a centre for cultivating and nurturing young scholars, particularly in econometrics and financial econometrics. A milestone was passed at the end of 2009, when the Laboratory of Econometrics at Xiamen University was designated a Key Laboratory of the Chinese Ministry of Education. It was the first Key Laboratory for economics and WISE is proud to host such a laboratory.



# ABOUT THE PROGRAMME

WISE and the MOE Key Laboratory of Econometrics at Xiamen University take advantage of their large number of staff with international academic backgrounds in econometrics, finance and experimental economics and extensive international academic resources to hold annual summer programmes focusing on these research fields in order to provide young

### > Enrolment:

This year's summer programme will enrol a maximum of 200 registered students, with priority given to Master's and PhD students in their second-year or above and to young scholars at domestic and overseas universities and institutes who majored in economics, finance, management, mathematics or statistics. Applicants should be adequately proficient in English and have a strong academic background in statistics.



## > Applications:

Application for places on the summer programme will be open from May 1<sup>st</sup> to June 31<sup>st</sup>. The list of those who have been accepted will be published on the WISE website and formal admission letters will be sent to the successful applicants.

Successful applicants must register at the time fixe, be actively engaged in academic activities during the summer programme, and abide by the rules and regulations of the summer programme and Xiamen University.

Applications should be submitted online and a fax of the completed application form bearing the signature of the applicant and stamped by the applicant's advisor or the applicant's college authorities sent to WISE.

# INTRODUCTION

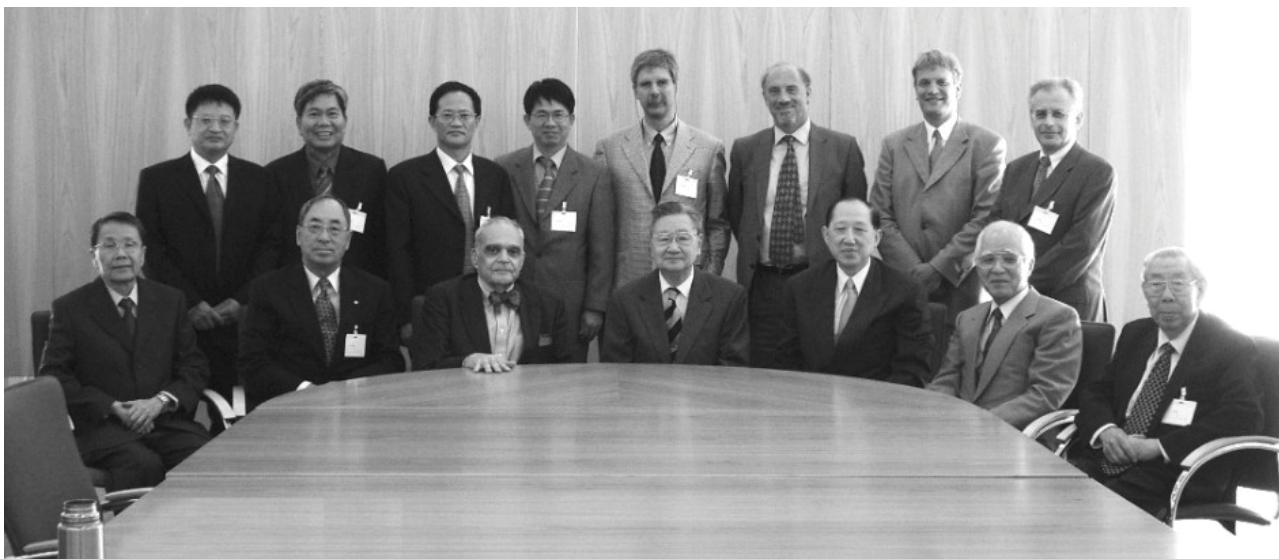

# Scholarships

---

## Types and eligibility for scholarships:

1. Subject to the Regulations for Obtaining Scholarships, the Xiamen Academy will provide a limited number of scholarships to appropriately qualified applicants (both Chinese Mainland and Non-Chinese Mainland participants) on a selective basis.
2. The Xiamen Academy offers two types of scholarships:
  - 2.1. *A-type scholarship, which includes:*
    - (1) *Full exemption of the registration fee;*
    - (2) *A subsidy towards return travel between partici-*

*pant's home and Xiamen:*

- a. *US\$ 400 for Asian participants (excluding Chinese Mainland participants), or*
  - b. *US\$ 600 for non-Asian participants, or*
  - c. *Full reimbursement to round-trip hard-seat train tickets for Chinese Mainland participants.*
- 2.2. *B-type scholarship includes full exemption of the registration fee.*

3. Application for scholarships must be submitted on a separate typewritten document indicating the type of scholarship applied for, accompanied by supporting documents.

## Scholarship Regulations

---

### Regulations for Obtaining Scholarships

#### *Article 1*

Each year, Xiamen Academy makes available a programme of scholarships which are awarded on consideration of such factors as academic performance, financial status and the type of country of origin.

#### *Article 2*

Recipients of scholarships must undertake to comply strictly with the provisions of these regulations concerning their obligations. None of the documents supplied by candidates in support of a scholarship application will be returned, so university certificates must be provided in the form of certified copies.

#### *Article 3*

Applications for a scholarship must be typewritten and accompanied by supporting documents, and must be received by the Secretariat, by post only, not later than 30<sup>th</sup> April 2011.

#### *Article 4*

The Curatorium will examine all applications received

before the deadline. It will produce a list of those who will receive a scholarship. However it is in no way bound by any recommendation that it receives.

#### *Article 5*

The Curatorium's decisions will be notified to the persons concerned during the month of May.

#### *Article 6*

The scholarship will be paid to each recipient during the period of summer programme.

#### *Article 7*

Recipients of scholarships must attend the Academy's courses throughout the session.

#### *Article 8*

Any failure by a scholarship recipient to comply with the obligations laid down by these regulations will result in the withdrawal of the scholarship; moreover, the Academy reserves the right to demand the reimbursement of sums already paid to the recipient.
